2. Approval of Agenda

3. Approval of Minutes – October 2023

4. President's Report – Jennifer Throssell

- Insurance renewals as of midnight today current policies expires. We have renewed property, auto, liability insurance. Waving earthquake insurance due to high cost.
- Pavilion Title docs to use as collateral for SBA loan. Title needs corrections (address and corporation name). Changes were notarized and will be sent to title company for correction
 - Deadline extended to Dec 6, and they can extend again if needed with the documentation provided.
 - SBA will determine whether it will accept Pavilion as collateral. If it does not, they will require a special assessment to members. We will address this if and when we need to pursue that option.
 - Held Nov 1st executive session to create a resolution on who can interface and provide collateral. Pete and Jennifer have been named as directors

Treasurer's Report – Pete Heller

• Monthly financial report

- Income is 107% of YTD budget, in large part due to recovering delinquency accounts
- Expenses are 97% of YTD budget

Delinquency report

- Delinquencies have been declining
 - 31-60 days staying low
 - 91+ days have flattened out, but many have come current
 - Residents have been more receptive to coming current. Lot owners are less responsive, more moving into lien
 - \$43.7K recouped this year
 - Kudos to Cheryl for her efforts -

- We are open to working with people to come current, will put on plan
- Zeb asked why people are not current 31-60 days. Cheryl this number is significantly lower than historic. Usually people hand writing checks and they forget. We encourage auto pay or use ACH transfer. 65-70 on autopay, 5-15 on ACH pay
- Zeb asked if he can know who on the lots
 - If someone is converting their land to a home, their lot assessment changes to a resident assessment.
 - We do have a manifest of lot owners, you can request ownership information if you know the lot.
- Janelle Wilcox What are the bank fees they are mostly credit card fees. There is no fee for direct debit.

 - 1. No answer from West Valley Construction
 - Santa Ana designs come through today.
 - Met with county to get a fast-track emergency plan, they will come out an inspect so they know who to send the package to to expedite
 - Santa Clara County is aware of the issue have been reported even though they are private roads, the county needs to approve repair
 - SBA gives the money to OES (Office of Emergency services), it comes to us from COES
- Last month we discussed hardening the slide sites, especially on Alma
 - Jeff- No progress since last month. Has calls in but hasn't heard back yet. Hopes to hear from Scott Green tomorrow who can
 - Pete we need to get quotes, not just go with the first quote
- Lindbergh and Santa Ana are separate sites, separated by 150ft. Technically Linbergh is Fawn Trail, used to be a "timber log bridge"
 - The canyon joins the same
- FEMA has still not given a answer because it is private property and not a public roadway
 - FEMA and OES says the tree should be removed as part of the roadway work
- Fire station parking lot rental Pavilion parking has been striped, equipment removed
 - Other items in contract still outstanding, such as basketball hoop and parking blocks, they have until Dec 1 and then can call the contract complete. If they are not mmet, they still owe us rent.
- Pavilion Oak trees removed or trimmed of the dead parts. Safety repair
- Park border still in place we had asked it to be removed at last meeting
